WHEREAS, the Uttar Pradesh Data Center Policy, 2021 has been issued by Department of Information Technology and Electronics, Government of Uttar Pradesh vide Notification no. 4/2021/1792/78-2-2020/254 LC/2019 dated 28th January, 2021;

AND WHEREAS in paragraphs 7.1(d), 7.2(d) and 8.4 of the aforesaid policy, Data Center Parks/ Data Center Units under the said policy are eligible for financial and non-financial incentives related to electricity supply;

NOW, THEREFORE, in exercise of the powers under sub-section (4) of section 3 of the Uttar Pradesh Electricity (Duty) Act,1952 (U.P.Act no. 33 of 1952), the Governor, in the public interest, to execute this policy, is pleased to direct that the Data Center Units established under the Uttar Pradesh Data Center Policy,2021 shall be granted 100% exemption in electricity duty for a period of 10 years from the date of their commercial operation.
